Food Bank

In 2014, FamilyWorks distributed over 298 tons of nutritious food through the Food Bank and Delivery Program to 2,839 individuals and 2,021 households. There were 25,775 visits to the food bank and 1,800 deliveries of groceries to 75 homebound seniors.

Resource Center

In 2014, 721 families (2,006 individuals) were served through the Resource Center with free diapers, bus tickets, children's clothing, job support, individual advocacy, workshops and parent/child program. 2,228 resource or referrals were given. In addition, 25 teen parents receiving on-on-one advocacy and group support and 98 assistance efforts were recorded.
